- 1. Electricity Regulatory Commission (ERC) intends to procure Following Electronic/Electrical Goods and Machineries and invites sealed bids from eligible bidders for procurement of these goods. The bidder should be registered Supplier to supply following items under the prevailing act of GoN.

- **3.** Bidding documents may be purchased from the above address of ERC Sanogaucharan, Kathmandu by eligible bidders on submission of a written application, along with the notarized copy of renewed/valid company/firm registration certificate; VAT certificate; Income Tax Clearance Certificate for FY 076/77 and voucher of payment of a non-refundable fee as mentioned below on or before 17:00 PM of 30th days from first date of publication (i.e. 2078-02-17). The bid document fee should be deposited in the following bank.

- 4. Sealed Bids along with necessary documents must be submitted to the office of ERC (Procurement Unit-Room at 4th floor) on or before 12:00 noon on 2078-02-18. Documents received after this deadline shall not be accepted. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 5. Bids shall be opened in the presence of Bidders' representatives who choose to attend bid opening at 14:00 PM of 2078-02-18 at the meeting hall of ERC. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by the bid security amounting to amount mentioned below which shall be valid for minimum 30 days beyond the bid validity period of the bid. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No. 1100203000000 (Ko. Le. Ni. Ka., Lainchaur in name of Office Code 308213502 with beneficiary name Electricity Regulatory Commission) in Rastriya Banijya Bank, Thamel, Kathmandu. Absence of the bidder or their authorized representatives, however, shall not obstruct or prevent the opening of the bid in any way.
- 6. The ERC reserves the right to amend or correct and accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
